26-5-7.2	Recordkeeping requirements for approved chemical restraint drugs shall be identical to the recordkeeping requirements for animal euthanasia drugs.				
26-5-8.5	Does the facility comply with the requirements for possession, administration, purchase and storage of SP, SP compounds or the approved sedatives or tranquilizers for pre-euthanasia administration, as established by the Board? <b>DEA initial and biennial inventory.</b>				
26-5-9.1.	<b>Certified Animal Euthanasia Technicians shall maintain records at their place of business including, but not limited to: Check each CAET Log and Safe</b>				
26-5-9.a.	Identification of the animal euthanized				
26-5-9.b	Method utilized for the euthanasia of each animal				
26-5-9.c.	Drug administered, including dosage				
26-5-9.d.	The date of euthanasia				
26-5-9.e.	The method of sanitary disposal of the animal's remains				
26-5-9.f.	An inventory of all receipts, administrations, and distributions of Sodium Pentobarbital and/or Sodium Pentobarbital compound or the approved replacement drug of choice				
26-5-9.2.	The Certified Animal Euthanasia technician and the <u>administrators of the animal control facility, humane society or animal shelter</u> shall maintain the records in a current status on the business premises for a period of 3 years.				
26-5-10.1.	The Certified Animal Euthanasia Technician shall maintain all controlled substances, sedatives and tranquilizers under his or her authority in a properly secure and locked storage container when the Certified Animal Euthanasia Technician is not in the same room with the drug.				
26-5-10.2.	Only the Certified Animal Euthanasia Technician shall have access to the drug storage container. <b>Each CAET drug storage should be verified.</b>				
26-5-10.3.	The manufacturer's instructions shall be followed in the preparation of all lethal injections or chemical restraint drugs. <b>What sedation drug do they use? Is it a Board approved sedation drug?</b>				
26-5-10.4.	Needles shall be of medical quality, and shall not be used if they are dirty, clogged, barbed, or might otherwise cause unnecessary discomfort for the animal. Needles may not be used more than 5 times. <b>Board prefers clean needles.</b>				
26-5-10.5.	Syringes shall be of medical quality. They may be reused if they are properly cleaned. <b>How do they clean?</b>				
26-5-10.6	Needles and syringes shall be kept in the same secure storage as the lethal drugs and chemical restraint drugs.				
26-5-10.7	Needles and syringes shall be disposed of in a proper container, as required by law.
